Dear Mr. O'Neil,

I received your public records request Tuesday. (I am the public records request coordinator for the Public Utility Commission.) The PUC does not have any records that are subject to your request because this agency only regulates natural gas pipelines used to provide utility service. The PUC does not regulate pipelines used to transport petroleum products.

The agency's chief pipeline inspector reports that a former staff member did participate in an inspection of the pipeline you reference, but that he did so acting under the jurisdiction of a federal agency (Pipeline and Hazardous Materials Safety Administration - PHMSA) who deputized him for that specific inspection, and not under the jurisdiction of the PUC. Accordingly, any reports were made directly to by PHMSA and were not retained by the PUC.
