Dear Mr. Lyons:

I received your May 28, 2015 email in response to my seeking further clarification of your May 20, 2015 correspondence. I hope the weather conditions are now improving.

I have concerns when I receive a letter such as yours in response to a citizen inquiry concerning this 53 year old Pipeline. Especially since your company publically provided this information in 1999. I am also quite surprised that as the Operations Manager of the Northwest Division here in the Northwest, Mr. Andrew Holbrook through you would be taking this type of position.

As conveyed to him and later you by voicemail, my family lives in a community next to the Kinder Morgan Pipeline (Pipeline) The school in which my son will be attending is situated adjacent to the Pipeline. I can understand that your office may be gun shy after having to litigate issues with the traditional environmentalist groups that are seeking to challenge construction or expansion of pipelines. That is not my motivation or desire. My goal is really simple-to make sure that we are all safe, and there are on-going and continuous communications between Kinder Morgan including its subsidiaries and the various public and private resources we have to ensure the safety of our communities here in Oregon and specifically Wilsonville.

Background

It is my understanding the Pipeline, which is approximately 113 to 115 miles in length, was originally installed 53 years ago by Southern Pacific Pipeline, a subsidiary of Southern Pacific Corporation and a sister subsidiary to the Southern Pacific Railroad. When first installed, the Pipeline was originally buried 4 to 4 ½ feet underground and travelled through undeveloped land. After the parent company's merger with Santa Fe in 1983, the Pipeline was acquired by the

newly formed company Santa Fe Pacific Pipelines, Inc. The Pipeline—often identified as the Santa Fe Pipeline— crosses a number of waterways including the Willamette River, which serves as the main water supply for Wilsonville, Oregon and other communities. The Pipeline is located within a mile upstream from the City of Wilsonville Water Treatment plant. Kinder Morgan acquired the pipeline in 1997 after it purchased Santa Fe Company. The Pipeline reportedly transports refined and highly flammable petroleum fuel products including gasoline, diesel, ethanol, and jet fuels. In 1999, it was reported by Kinder Morgan that it was pumping approximately 1.6 million gallons of fuel daily through the Pipeline under pressure 8 times more powerful than a fire hose. Since that time the demand for fuel has significantly increased, and the population and housing density surrounding the Pipeline has substantially risen since 1962. For example in 1969, the population of Wilsonville was only 1000 people and was situated substantially west of the Pipeline. The current population exceeds 21,000 and the density of the population within a few yards of the Pipeline path is substantially higher. The Pipeline travels through the play field of one public school in the area, and several dense communities in Sherwood and Wilsonville. Since the installation of the pipeline, the Willamette River has flooded Wilsonville twice first in 1964 and later in 1996. On September 13 1989, a construction worker drove a bulldozer through a stream bed, rupturing the Pipeline in Marion County, Oregon and causing 30,000 gallons of gasoline to spill in Mill Creek. As a result of this incident, neighborhoods had to be evacuated due to the fumes, and there were widespread concerns that the vapors would ignite and endanger these neighborhoods. There have been other incidents since then.

The 53 year old Pipeline travels through/or is in close proximity to Rivergreen, Fox Chase, Moreys Landing, Merryfield, Hazelwood, and Villebois communities. The Pipeline is within a few yards of a very large apartment complex and pre-school. It travels underneath a critical artery for our City-Wilsonville Road. A road that on a good day remains highly congested. It travels under the Inza R. Wood Middle School Athletic Field adjacent to two schools. It is also within 100 yards of the Lowrie Primary School. While I have tailored my focus on the community in which I live. My concerns extend to the entire 115 mile path of the Pipeline.

On June 10, 1999 in Bellingham, Washington, a gasoline pipeline operated by Olympic Pipeline Company ruptured as the result of an improperly configured relief valve. 277,000 gallons of gasoline spilled in the adjacent Hanna and Whatcom Creeks. The fumes were overwhelming requiring the evacuation of local residence. The gasoline vapors soon exploded. Three children died. Bellingham's water treatment plant which was located near the pipeline and the explosion was destroyed. The authorities noted that the destruction and death toll was much lower than what would be expected from such a large explosion. The reason-the explosion was centered in a large forested park. We do not have this luxury of uninhabited space along a significant portion of the path of this Pipeline.

On September 9, 2010 there was the San Bruno pipeline explosion which was reported to have had a wall of fire 1,000 feet high. It leveled 35 houses and compromised a water main impacting the ability of first responders to fight the fires. It killed at least 8 individuals injuring 58. The cause of the explosion-numerous defective welds in the 54 year old pipeline.

In lights of this potential threat, there is a substantial public interest for information about the current safety of the Pipeline, the safety measures that are currently in place to prevent pipeline accidents, contingency plans in case there are accidents, and its impact to the soil, and water in which it travels through. There is also a substantial public interest that the Pipeline itself be replaced with more modern materials and construction methods. There is a substantial public interest that more modern technologies are utilized to inspect the structural integrity of the Pipeline. There is a substantial public interest that safety plans and drills between Kinder Morgan and the relevant local, state, and federal agencies are implemented in order to insure the safety of Oregon Citizens.


Request for further Clarification
