2. A complete copy of the current disaster response plan(s) in which District and its schools are a participant that address/respond to issues associated with the rupture or damage to the Pipeline.

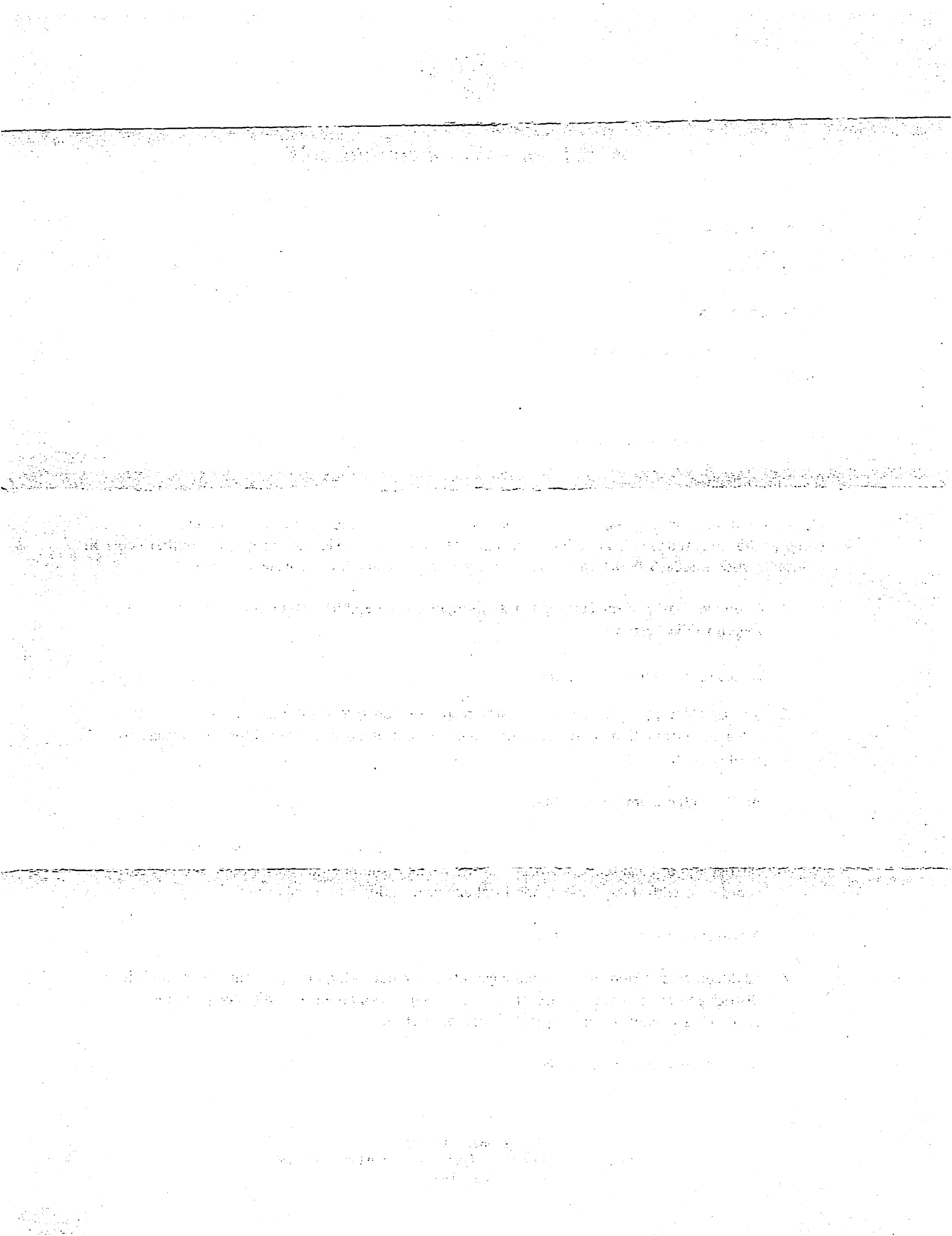
